**Submitting Form AS 4 for Reaffirmation Self-Study & Candidacy Benchmarks**

This form is used to assist the COA in the evaluation of the program's compliance with the accreditation standard below:

**4.0.3:** The program uses Form AS 4(B) and/or Form AS 4(M) to report its most recent assessment outcomes for each program option to constituents and the public on its website and routinely up-dates (minimally every 2 years) its findings.

All programs accredited by the Council on Social Work Education's Commission on Accreditation (COA) are required to measure and report student learning outcomes. All students are assessed using a minimum of two measures on their mastery of the nine competencies that comprise the Educational Policy and Accreditation Standards (EPAS) and any additional competencies programs may choose to add. These holistic competencies reflect the dimensions (knowledge, values, skills, and cognitive & affective processes) of social work practice that all social workers are expected to master during their professional training.

Programs determine a percentage-based benchmark for each competency and determine an outcome-measure benchmark (minimum score) for each measure. The competency benchmark (which can differ for each competency) represents the minimum percent of students the program expects to have achieved the outcome measure benchmarks in both/all measures for each of the nine competencies. The program then determines the percentage of students that attained each outcome measure (e.g., minimum score or higher), and aggregates the percentages for both/all measures together to obtain the percentage of students demonstrating competence inclusive of two (2) or more measures. The result of aggregating both/all outcome measure percentages provides the percentage of students achieving the competency benchmark. An aggregated percentage at or above the competency benchmark is considered achievement of that competency. If the program has more than one program option, the program must report data for each program option, and also an aggregate of all program options combined to determine an overall percentage of students across all program options achieving the competency benchmark.

**Posting Form AS 4 for Ongoing Compliance with AS 4.0.3**

Per the requirement of CSWE COA's recognizing body, the Council on Higher Education Accreditation (CHEA), and accreditation standard 4.0.3, programs must post this form publicly on its website and routinely up-date (minimally every 2 years) its findings. Dimension(s) assessed:	Knowledge, values, skills, affective and cognitive processes
When/where students are assessed:	The instrument is completed online during the last two weeks of field practicum of the second semester of field education.
Who assessed student competence:	The student's field instructor completes the Field Instrument under the direction of the Field Director. The Program Director has oversight of the review of assessment data.
Outcome Measure Benchmark (minimum score indicative of achievement) for Competencies 1-9	3 or better on a 5 point scale, for a given item (practice behavior) = competent or better performance. The outcome measure benchmark is a score of 3 or higher on every item (practice behavior) within the a given competency.

Dimension(s) assessed:	Knowledge
When/where students are assessed:	Students were required to complete the online instrument during the final two weeks of the semester in which they completed the field practicum.
Who assessed student competence:	The Program Director has oversight of administering and reviewing the data for this instrument.
Outcome Measure Benchmark (minimum score indicative of achievement) for Competencies 1-9.	Correct response on at least 50% of items within a competency.
Competency Benchmark (percent of students the program expects to have achieved the minimum scores, inclusive of all measures) for Competencies 1-3 & 6-9:	85%
Competency Benchmark (percent of students the program expects to have achieved the minimum scores, inclusive of all measures) for Competencies 4 & 5.	80%
