#### **Application Requirements and Process**

- Your application must be received by or before April 19, 2024. Late applications will not be considered.
- 2. Applicants must meet the following criteria:
  - a. Possess either a master's or doctoral degree or be currently enrolled either in a master's or doctoral program.
  - b. Reside in the U.S. or Canada or be currently enrolled in an American or Canadian university program.
  - c. Be available to carry out research at the Clarke Library during the summer of 2024.
- 3. Your application must be filled out completely and signed.
- 4. Your application will become the property of the Clarke Historical Library, Central Michigan University. Text from the winning application may be used in all or part in any press release or other publicly disseminated material announcing the awarding of the grant and the research the grant will support.
- 5. Upon notification of the award, should you determine that you are no longer available to conduct research at the Clarke Historical Library during the summer of 2023, the director of the Clarke Historical Library, in consultation with the committee, may withdraw the award.
- 6. Should you fail to conduct your proposed research at the Clarke Historical Library during the summer of 2024, the director of the Clarke Historical Library, in consultation with the committee, may withdraw the award.

#### **Application Review Process:**

The director of the Clarke Historical Library will convene a committee composed of three or more individuals to consider all applications received on or before April 19, 2024. The composition of the committee, and the decisions made by the committee, are final. In ranking the proposals, the committee will consider the following criteria:

- a. How the proposal will use the Clarke's children's literature collections.
- b. Potential contribution of the proposal to the literature of the awardee's discipline.
- c. Likelihood of publication or other public distribution of the research. Preference will be given to proposals having a greater demonstrated likelihood of public distribution. Applications of a purely personal nature will not be considered.
