School of Accounting Scholarships*

- School of Accounting Transfer Student** – Transfer students to CMU. Must have earned at least 30 credit hours of which six credit hours are in ACC.
- Craig and Karen Barnhart Accounting Scholarship** – Undergraduate, Accounting major, minimum GPA of 3.0.
- James O. Beard, Jr. Scholarship** – Undergraduate, junior or higher status, Accounting major, minimum GPA of 3.0. Preference given to an active member of an accounting-related RSO.
- Bohannon Family Endowed Scholarship** – Undergraduate, CBA admitted, Accounting major, 3.0 overall, 3.20 Accounting. Need-based Scholarship.
- Crawford & Winiarski/Rodney Crawford Scholarship in Forensic Accounting** – 3.7 GPA Overall, and 3.7 GPA Accounting, junior or senior, with expressed interest in a career of public accounting and/or forensic accounting.
- Deloitte LLP Award** – Student must be enrolled in the CBA, majoring in accounting, with a minimum GPA of 3.3.
- Robin Dilling Vatalaro Scholarship** – Student must be a senior majoring in accounting, who has a minimum GPA of 3.00.
- Financial Executives Int'l Western Michigan Chapter Scholarship** – Student must be a junior or senior majoring in accounting, who has a minimum GPA of 3.25 overall and 3.50 in their major. Full-time student who is heavily involved in extracurricular activities such as accounting or finance clubs (e.g. Beta Alpha Psi), and/or raising a family, involved in athletics, or working an outside job while in school. Recipients are requested to attend a FEI-WM chapter dinner meeting for an opportunity to network with financial executives and be recognized for their achievement.
- Jakolat Family Endowed Scholarship** – Established in 2017 for an accounting major in their junior or senior year with a minimum 3.00 GPA. Preferences are as follows, first preference for a student who graduated from Alma High School, Alma, Michigan, second preference for a student who graduated from a high school within Gratiot County, Michigan, third preference for a student who graduated from a high school within Kent County, Michigan.
- Philip Kintzele School of Accounting** – Established in 1986 for a non-Centralis scholar School of Accounting senior. Recipient will be pursuing an MBA and will have completed at least 100 credit hours with the highest overall grade point average of those applying for the scholarship.
- Masters of Business Administration/Accounting Scholarship** – CMU Accounting BSBA Graduate completing MBA, 3.4 undergraduate GPA, 550 GMAT, cannot receive a Graduate Assistant position.
- Maner, Costerisan & Ellis, P. C. Scholarship** – Minimum 3.3 GPA. Resident of Clinton, Eaton, or Ingham County.
- Linda Jaye Masak Memorial Scholarship** – 3.7 GPA Overall and 3.7 GPA Accounting.
- Doeren Mayhew Scholarship** – Undergraduate accounting students enrolled in the College of Business Administration; preference for distribution is for the funds to be given to two juniors and three sophomores. The recipient will be performing at a high level in their academic coursework (at least a 3.5 overall GPA), in particular their accounting coursework. Selection will be based upon overall GPA, performance in accounting courses, faculty recommendations, demonstrated leadership in College related activities and the potential for success following completion of the degree. Preference should be given to applicants who are available to intern with Doeren Mayhew and willing to consider full time employment with Doeren Mayhew upon graduation.
- Michael F. & Mary F. O'Donnell Endowed Scholarship** – Student must be a junior or senior majoring in Accounting. Must have completed a minimum of 60 credit hours with preference to a student demonstrating financial need. Minimum GPA of 3.00.
- Leonard E. Plachta Accounting Scholarship** – Student shall be a junior, senior, or master's degree candidate majoring in Accounting. Minimum GPA of 3.00 overall and 3.20 in accounting courses. Preference will be given to candidates who aspire to receive a Ph.D. in accounting and plan to teach at a collegiate level.
- Plante & Moran Scholarship** – 3.3 overall, 3.3 Accounting. Requires significant additional activity (e.g., work, sports, community service, or student groups).
- PricewaterhouseCoopers Accounting Undergrad Scholarship** – The recipient must be enrolled in the CBA with a major in accounting or accounting information systems. Student must have a minimum 3.5 overall GPA, in particular their accounting coursework. Selection will be based upon overall GPA, performance in accounting courses, faculty recommendations, demonstrated leadership in their College related activities and the potential for success following completion of the degree. Preference should be given to applicants that are available to intern with PricewaterhouseCoopers and willing to consider full time employment with PricewaterhouseCoopers upon graduation.

PricewaterhouseCoopers MBA Award – Student applying for the MBA program with an emphasis in Accounting, with a minimum GPA of 3.5. GPA requirements may be relaxed if the student has completed an internship or is involved in the Honors Program. Significant consideration will be given to activities that demonstrate leadership and the ability to effectively manage multiple responsibilities.

Reed Family Endowed Scholarship – Junior or senior with a 3.5 GPA. This scholarship will alternate yearly between an Accounting Major and a Marketing Major. (Marketing majors are in the odd numbered years; 2013, 2015).

The Rehmann Group Scholarship – 3.3 GPA Overall, 3.3 Accounting GPA. Preference given for student working towards the advancement of minorities in accounting and business.

James & Ann Rosloniec Endowed Scholarship – Student must be at least a junior, majoring in Accounting. Preference given to transfer student from Kent, Muskegon, or Ottawa County that has completed a minimum of 60 credit hours and demonstrates financial need. Minimum GPA of 3.50.

Paul S. Spece Award – Student must be a junior or senior, majoring in Accounting or Accounting Information Systems, who has a record of academic excellence.

Grant G. Skomski & Mary Jane Flanagan – Award alternates between the School of Accounting and the School of Music. Must be a junior or senior with a major in accounting or instrumental music. Minimum GPA of 3.25. Preference will be given to a student from Michigan. Must demonstrate financial need.

Please be advised:

- Scholarships are not automatically renewable. Students who receive a scholarship should be advised that there is no guarantee they will receive the scholarship in subsequent years. Students must reapply for scholarships each year.
- Some scholarship awards are designated for students with specific majors. In these cases, students who change their major may be ineligible for previously awarded scholarship funds.

Other awards for accounting majors available through the dean's office:

Richard and Virginia Feusse Scholarship – Student must be enrolled in the CBA with a minimum GPA of 3.50, with an interest in the study or accounting or finance. Award may be renewable for up to four years of full-time continuous enrollment providing that a 3.50 cumulative GPA is maintained. Must have filed FAFSA to determine financial need. (This scholarship is awarded through the dean's office; see the CBA Dean's Office link).

Kench Scholarship – Student must be a Michigan resident in their junior year with a minimum GPA of 2.75, majoring in one of the following areas: Management, Marketing, Human Resources or Accounting. (This scholarship is awarded through the dean's office; see the CBA Dean's Office link).

Mark & Michelle Szymczak – Student must be a major in Business Information Systems or Accounting. Preference given to students who are studying SAP and have strong leadership on campus. Minimum GPA of 3.00. (This scholarship is awarded through the dean's office; see the CBA Dean's Office link).
