



This evaluation is for students who have taken Defense Acquisition University courses and are interested in Central Michigan University's Master of Science in Administration (MSA) Program. Transfer credit from DAU is the best used on the MSA Program concentrations in Acquisitions Administration or Logistics and Acquisitions (name change effective fall 2021), General Administration or Leadership. Up to nine (9) hours of transfer credit may be considered for the Acquisitions Administration (AA) and General Administration (GA) concentrations. DAU courses with a focus on leadership skills may be transferred to the Leadership (LDR) concentration. The chart below specifies the appropriate concentration. ACE (American Council on Education) credit level recommendations come from [The National Guide to College Credit for Workforce Training](#):

Transfer credit must be identified as graduate (G) level on the DAU transcript and noted as having an ACE evaluation. **The transfer credit evaluation in this document is based on courses taken at DAU. Evaluation of similar courses taken through other providers will rely on the [ACE](#) recommendation for the credit level. For example, CON 090, CON 280, CON 290 and CON 360 taken through another provider are recommended for undergraduate credit by ACE.**

A maximum of 18 hours of prior learning and graduate transfer credit may be used towards the MSA degree. A maximum of twelve (12) hours of Prior Learning credit may be used on the degree. Prior Learning Assessment policies are similar to the graduate transfer credit policy in that work experience and training experience submitted for Prior Learning Assessment must be within the seven (7) year timeframe prior to the student's graduation. Under the reconfigured Logistics and Acquisitions concentration, transfer credit may be used for the MSA 611 and 6 hours of electives. **This information is current as of February 2023. Career Fields have been replaced by Functional Areas and requirements for DAW have changed. DAU new and revised coursework is currently being reviewed by ACE. The MSA office anticipates updating the DAU transfer credit information in summer/fall 2023.**
