Professional Accreditation: The Department of Recreation, Parks and Leisure Services



Central Michigan University's programs of *Recreation and Event Management, Outdoor and Environmental Recreation* and *Therapeutic Recreation* are all accredited by the <u>Council on Accreditation of Parks, Recreation, Tourism, and Related Professions</u> (COAPRT). COAPRT accredits baccalaureate programs in parks, recreation, tourism, sport management, event management, therapeutic recreation and leisure studies offered at regionally accredited institutions within the United States and its territories and at nationally accredited institutions in Canada and Mexico. The CMU program was the first program in Michigan to attain this recognition and has been continuously accredited since 1982.



COAPRT is accredited by the <u>Council on Higher Education Accreditation</u> (CHEA). CHEA requires their accredited organizations to inform the public about "degree and accreditation mills". Information regarding these entities is available in video format <u>here</u>. As stated by CHEA:

"Degree mills and accreditation mills mislead and harm. RECREATIONAL THERAPY – STUDENT LEARNING OUTCOME DATA

The Recreational Therapy (RT) program gives students experience and knowledge needed to be successful in the field of therapeutic recreation. The mission of the program is "To inspire students to transform client lives through evidenced based Recreation Therapy services." Through both classes and applied experiences, our curriculum focuses in the areas of behavioral health, physical medicine and rehabilitation, geriatrics, developmental disability, facilitation, administration, and programming. Student select one of two academic tracks depending on their long term career goals: 1.) Bachelor of Science students (those interested in graduate school) complete a 15-week internship coupled with additional coursework in the social sciences, natural sciences, and humanities. Students enrolled in the Bachelor of Applied Arts (seek immediate work in therapeutic recreation) complete both a 15-week clinical and a 15-week non-clinical internship instead of taking extra coursework in social sciences, natural sciences, and humanities. Upon graduation, students are prepared to work in a variety of therapeutic recreation settings including inpatient and outpatient behavioral health, PM&R, long-term care, Veteran's Administration Hospitals, community parks and recreation inclusion programs, pediatric and adult medical specialty camps, and adapted sport.
