It is preferred that the recipient of this award be a first-generation college student who has financial need. The student must have a desire to serve and make a better society by engaging in professional work that promotes natural resources and educates our youth about natural environments. This scholarship will be geared toward young professionals who desire to help our citizens enjoy a lifetime of activity, balance, sustainability and productivity.

Award:

A scholarship of **\$1,000.00** will be given to a college student who meets the following criteria:

Eligibility Factors:

- 1. Signed Outdoor Recreation Major from the RPL Department.
- 2. First generation college student preferred but not required.
- 3. 3.0 Overall GPA.
- 4. Sophomore, Junior or Senior status.

Procedure:

- a. Completed cover sheet
- b. Response to two questions
- c. Copy of student transcripts (does not need to be official)
- d. Work / Service reference (cannot be from a RPL professor)
- e. Resume
- 2. All applications that are received by the designated deadline will be evaluated by the faculty review committee to determine eligibility for interviewing.
- 3. Applicants will be notified of the selection process results no sooner than 30 days after the submission deadline.

Criteria Used for Evaluation:

- 1. Materials must be completed and presented in a professional manner.
- 2. Demonstrated leadership in RPL through any of the following: practical experience, community service/volunteerism, professional development experiences.
- 3. Demonstrated focus on career-minded goals and objectives.
- 4. Work Service reference, with original signature.
