PUBLIC COMMENT RELATED TO AGENDA ITEMS:

Six speakers requested to address the Board of Trustees related to agenda items. They spoke in the order that their requests were received by the Board Secretary.

- 1. Madeline Thomas, student, spoke about keeping affordability of the university at the forefront.
- 2. Teresa Homsi, student, also spoke about affordability and quality education from a consumer perspective.
- 3. Abigail Slate, student, spoke about concerns related to the Washington Commons Residential Community project, including affordability, and equitable and inclusive access to housing. Urged the university to take a step back and gather more input, consider other options.
- 4. Katrina Piatek-Jimenez, faculty member, spoke about concerns regarding the Washington Commons project. She is concerned about the distance of Lot #75 from Anspach/Pearce Halls and the removal of Kewadin family housing. Proposes only two buildings total.
- 5. Joanne Dannenhoffer, faculty member, also spoke about concerns related to the Washington Commons project and its potential financial effect on the university.
- 6. Zach Parfeniuk, student, reading for David Kinney, faculty member, spoke about his thoughts on the Washington Commons project; he agrees new housing options would be beneficial to the university, but addressed his concerns on the timeline of the project. Suggests postponing decision to June or September 2023.





Central Academy





Holly Academy





International Academy of Flint





Macomb Academy





Old Redford Academy




For more than 20 years, the school has served the Detroit community with a mission focused on providing a learning environment that will develop children to reach their maximum potential and to become productive members of a changing world.

Kensington Woods Schools





AUTHORIZATION OF PUBLIC SCHOOL ACADEMY AND APPOINTMENT OF INITIAL BOARD OF DIRECTORS

Creative Montessori Academy

Recitals:

- 1. The Michigan legislature has provided for the establishment of public school academies as part of the Michigan public school system by enacting Act No. 362 of the Public Acts of 1993.
- 2. The Michigan legislature has mandated that public school academy contracts be issued on a competitive basis taking into consideration the resources available for the proposed public school academy, the population to be served by the proposed public school academy, and the educational goals to be achieved by the proposed public school academy.
- 3. The Michigan legislature has mandated that authorizing bodies establish by resolution the method of selection, length of term, and number of members of the board of directors.
- 4. According to this legislation, the Central Michigan University Board of Trustees, as the governing body of a state public university, is an authorizing body empowered to issue contracts to organize and operate public school academies.
- 5. The Central Michigan University Board of Trustees has requested applications for organizing public school academies and has reviewed the applications according to the provisions set forth by the Michigan legislature.
- 6. The Central Michigan University Board of Trustees has established chartering policies in addition to the policy titled *Public School Academy: Method of Selection, Appointment, and Removal* as required by the Michigan legislature.
- 7. The university president or designee has recommended the issuance of a contract to charter as a public school academy to Creative Montessori Academy for a term not to exceed five (5) years.
- 8. The university president or designee has recommended for appointment Amphy Negron to a term which expires August 30, 2023; Walker Evans to a term which expires August 30, 2024; Donald Treadwell to a term which expires August 30, 2025; and Jessica Pinto and Tammy Duty to terms which expire August 30, 2022, and to additional terms which expire August 30, 2026.
- 9. Creative Montessori Academy's application has been submitted under Act 362 of the Public Acts of 1993, being part 6A of the Revised School Code, being sections 380.501 to 380.507 of the Michigan Compiled Laws.

BE IT RESOLVED, That the University Board approves and authorizes the execution of a contract to charter a public school academy to Creative Montessori Academy and authorizes the chair of the board of trustees to execute a contract to charter as a public school academy and related documents between Creative Montessori Academy and the Central Michigan University Board of Trustees, provided that, before execution of the contract, the university president or designee affirms that all terms of the contract have been agreed upon and Creative Montessori Academy is able to comply with all terms and conditions of the contract.

BE IT FURTHER RESOLVED, That the following individuals are appointed to serve as initial members of the board of directors of Creative Montessori Academy commencing the date upon which the oaths of public office are taken, but not prior to July 1, 2022.

Initial Members of the Board of Directors. The initial board of directors of Creative Montessori Academy shall consist of five (5) positions.

ACCEPTANCE OF TERMINATION OF CHARTER CONTRACT

Orchard Academy

Recitals:

- 1. At its December 7, 2017, meeting this board authorized the issuance of a contract to charter as a public school academy to Orchard Academy (formerly Detroit Bridge Academy). On April 2, 2019, the contract was effective.
- 2. According to section 10.5 of the terms and conditions of the charter contract, the academy board, by majority vote of its directors, may for any reason, request termination of this contract.
- 3. The Academy was unsuccessful in recruiting and enrolling students sufficient to sustain viability.
- 4. The Academy board, at its properly noticed board meeting on March 21, 2022, has requested immediate termination of the charter contract.

BE IT RESOLVED, That the Central Michigan University Board of Trustees approves the proposal for termination of the charter contract effective immediately.

BE IT FURTHER RESOLVED, That the Central Michigan University Board of Trustees waives the six (6) month advance notice requirement contained within section 10.5 of the terms and conditions of the charter contract for termination.

BE IT FURTHER RESOLVED, That the Central Michigan University Board of Trustees hereby directs the Orchard Academy board to wind up and dissolve the Academy in accordance with applicable law.

STUDENT HOUSING, ENROLLMENT AND CMU BUDGET PRIORITIES

WHEREAS, we confirm the attributes of the Washington Commons Residential Community project as critical to future growth, attracting students and meeting the market need of students today and in the future: and

WHEREAS, the Board of Trustees and administration have listened, and will continue to listen, to the campus and broader community and want to include their ideas; and

WHEREAS, the macro conditions of the capital market combined with continued navigation of the university's fiscal and enrollment challenges suggest that now is not the right time to embark upon this project;

NOW BE IT THEREFORE RESOLVED, That the planning completed to date for the Washington Commons Residential Community project and ancillary works is supported in principle and will be revisited by the Board of Trustees on or before September 30, 2022.

First preference is given to student(s) pursuing a Master of Science in Administration (MSA) degree with a concentration in Leadership or Logistics and Acquisition (or their equivalent), who are actively employed by the Department of Defense, and/or have been Honorably Discharged Veterans of the U.S. Military Services, and/or are currently serving in the Military active-duty guard or active reserve. Second preference is given to student(s) pursuing a Master of Science in Administration (MSA) degree who are actively employed by the Department of Defense, and/or have been Honorably Discharged Veterans of the U.S. Military Services, and/or are currently serving in the Military active-duty guard or active reserve. Third preference is given to student(s) pursuing a Master of Science in Administration (MSA) degree with a concentration in Leadership or Logistics and Acquisition (or their equivalent). Fourth preference is given to student(s) pursuing a Master of Science in Administration (MSA) degree. The scholarship may be renewed

up to one time following the initial award, up to 2 times total, and qualified recipients must be enrolled in a minimum of six credit hours.

Charles and Karen Mallon Scholarship

Established in 2022 by Charles "Chuck" '76 and Karen Mallon for students of any major beginning their freshman year who are pursuing an undergraduate degree at Central Michigan University. Qualified recipients must demonstrate financial need. Preference will be given to first-generation college students, as verified by OSFA. The scholarship is renewable up to a total of four years, as long as a cumulative minimum 2.0 GPA is maintained.

Pam Rowland Student Publications Endowment Fund

This endowment was established in 2022 to recognize the outstanding contributions made by Pam Rowland while working in the Student Publications Department at CMU. Pam, who passed away in 2015, is remembered by many for her high degree of excellence and her caring attitude for students. It is the intent of this fund to support the operating needs of the department.

Gary and Barbara (Anderson) Russell Free Busing Endowment

Established in 2022 by Gary '66, '70 and Barbara (Anderson) Russell '66, '70. To provide a means for K-12 students to travel to the Gerald L. Poor Museum as well as the Museum of Cultural and Natural History on the campus of Central Michigan University. Gerald L. Poor is the uncle of Barbara (Anderson) Russell and the family is proud to have him honored with the naming of this museum. Their intent is to make sure young people have the opportunity to visit, enjoy, and learn from the programming, exhibits, and events surrounding the facilities, which are all delivered by CMU students in the Museum Studies Program.

Paul and Judy Sare Scholarship

Established in 2022 by Paul '66 and Judy Sare '65, both having received their degree from Central Michigan University. The recipient of the award will be a full-time undergraduate student enrolled in the College of Education and Human Services pursuing elementary education within the department of Teacher Education and Professional Development. Recipient will also demonstrate financial need while maintaining a cumulative minimum GPA of 3.0.

James H. Wanty Endowed Award

This scholarship was established in 2022 by James H. Wanty. James (Jim) Wanty is a 1971 graduate of Central Michigan University who double majored in Economics and Marketing. Jim was the fourthgeneration owner of O&W Inc. beverage wholesaler based in Ypsilanti, MI, until its transfer to a fifth generation, under the leadership of his children. This is a renewable scholarship for students within the College of Business Administration majoring in Personal Financial Planning or Finance with an overall GPA of at least 3.0. Preference will be given to students who demonstrate a commitment to the advancement of underrepresented minorities in the wealth management profession. The scholarship will provide up to the full cost of enrollment based on funds available in the endowment spendable.

Endowment Criteria Changes

Bila-Michels Professional Development Experience Scholarship

This scholarship was established in 2013 by James J. '83 and Kallie Bila '85 Michels. James (Jim) and Kallie wish to assist students studying Journalism, Broadcast & Cinematic Arts or Integrative Public Relations in broadening their experiences and knowledge through internships or professional development opportunities. Recipients must be majoring in Journalism, Broadcast & Cinematic Arts or Integrative Public Relations. The scholarship will support their pursuit of an internship or other professional development opportunities including, but not limited to, conferences, seminars, workshops, competitions, etc.

McDonald Future Science Teachers Scholarship

This scholarship was established in 2006 by Jim and Jamie McDonald. Dr. McDonald has served as a Professor of Science Education in the Teacher Education and Professional Development Department and Mrs. McDonald has served as an Executive Secretary in the EHS Center for Student Services. Income from the endowment will support a renewable scholarship for a sophomore, junior, or senior pre-service teacher pursuing a degree in elementary education who has a stated interest in teaching science, with a minimum 3.5 GPA. Students should write a personal statement addressing their involvements in science teaching, science education organizations and providing science to children, working with students, and why they would like to teach science to elementary students in their own classroom.

Katherine Ardis Ux Endowed Award in Art

This scholarship was established in 2001 by Evart and Dorothy Ardis in honor of Evart's sister Katherine Ardis Ux, a former art department faculty member and accomplished artist. Katherine taught at CMU from 1944 until her retirement in 1975. Katherine was a widely acclaimed artist known for her textiles and weavings. Her artwork was displayed in galleries throughout the United States, including the Smithsonian Institution. Her creations were also featured in numerous public and private collections, including the Detroit Institute of Arts, the St. Paul Gallery in St. Paul, Minn., the Cooper Union in New York and CMU. She received numerous awards for teaching during her career and an honorary Doctor of Fine Arts degree from CMU in 1997. In a 1997 interview, Katherine said, "I have always felt so fortunate to have been an art teacher. I would like to do it all over again." Katherine passed away in 1999. This endowment supports awards for undergraduate students entering their senior year pursuing a degree in the Department of Art and Design. Preference given to students who intend to pursue further study or conduct research in the field of art in a master's program or other type of structured art program after completing their undergraduate degree.
